

TUITION REBATE FOR QUALIFIED UNDERGRADUATES

In 1997, the Texas Legislature approved a tuition rebate plan as a financial incentive to students receiving their first baccalaureate degree if they meet certain requirements upon graduation. This program is authorized by the Texas Education Code, Section 54.0065.

Eligibility – To be eligible for a rebate under this program, students must meet all of the following conditions:

- Must have enrolled for the first time in an institution of higher education in the Fall 1997 semester or later.
- If enrolled in an institution of higher education for the first time in Fall 2005 or later, students must graduate within four (4) calendar years for a four-year degree or within five calendar years for a five-year degree if the degree is in architecture, engineering, or any other program determined by the Texas Higher Education Coordinating Board to require more than four years to complete.
- They must be requesting a rebate for work related to a first baccalaureate degree received from a **Texas public university**.
- They must have been a resident of Texas, and have been entitled to pay resident tuition at all times while pursuing the degree.
- They must have **attempted no more than three (3) hours in excess** of the minimum number of semester credit hours required to complete the degree under the catalog under which they were graduated. Hours attempted include:
 - transfer credits
 - course credit earned exclusively by examination (except that, for the purposes of this program, only the number of semester credit hours is treated as hours attempted)
 - courses that are dropped after the official census date (withdrawn courses that appear as a “W” on the transcript)
 - for-credit developmental courses
 - optional internship and cooperative education courses
 - repeated courses

Responsibilities of Students:

- Students desiring to qualify for tuition rebates are responsible for complying with all rules and regulations related to administration of the program.
- Students desiring to qualify for tuition rebates are solely responsible for enrolling only in courses that will qualify them for the rebates.
- A student who has transferred from another public or independent institution of higher education is responsible for providing to the institution awarding the degree official transcripts from all institutions attended by the student.

To Apply: Students must apply for rebates PRIOR to the date of the commencement ceremony for the semester in which you will graduate. It is your responsibility to ensure that the form is received in the Office of the Registrar, Room 122, University West Building, UHV, 3007 N. Ben Wilson, Victoria, TX 77901. (Fax: 361-580-5545)

- If you qualify, you will be notified by email approximately four weeks after commencement.
- If you do not qualify, you will be notified via your UHV email address.
- If you qualify, your rebate will be applied to any outstanding loans or other amounts owed.
- Upon final review by the Office of the Registrar and the Bursar’s Offices, your check will be mailed to the address specified on your Tuition Rebate application approximately six weeks after UHV’s commencement.
